## St Mary the Virgin, Harefield

The Parish Church of St Mary's is Harefield's oldest building and has been its spiritual heart for centuries. It is described as the Westminster Abbey of West Middlesex because of its wealth of monuments.

The Domesday Survey shows that Harefield had a priest; so presumably there was a Church here at this time.

The Newdigate family were influential in creating the building that now exists. The building has been added to significantly throughout the ages and there are still numerous references to this family.

The monument to Alice, Countess of Derby is a very visible feature to the right of the Altar. She came to Harefield in 1601 and died here in 1637.



South of the Church there is an Australian Military Cemetery, where one hundred and eleven men and one nurse who died in the Great War are buried. They were cared for in Harefield Park where Harefield Hospital now stands. Since 1921 there has been an annual Service on Anzac Day, 25 April, when flowers are laid on each grave by children from the village.
